ANNUAL REPORT OF THE COMMITTEE 2018

1 CHAIRMAN'S REPORT

I am delighted to write to you once again as Chairman of the Society. I remain extremely well supported by Tony Bone, our President, and by all the members of our hard working Committee. Catherine Palmer, late of the NHS and now very involved in Aldeburgh affairs including the Carnival Committee, has joined us on the Committee and sits on our Planning Sub-Committee where she has been a real asset. Our membership remains at around 400 households. Having such a large membership gives us a voice on matters affecting the Town, with the Town Council and other local bodies. We are also as keen as ever to recruit more members.

Relations with the Town Council remain excellent. Councillor Jones attends all of our main committee meetings, briefs us on town matters and feeds back our views. We have been helping follow up one of the actions from the Town Plan where we looked at how the appearance of the Town centre could be improved. We will be presenting our conclusions to the Town Council. We worked together on the successful Brick Dock campaign which saw the Society help fund the Town's representation at the Planning Inquiry which upheld the refusal of planning for the development of 42 houses in the AONB. Thank you to all who helped on this campaign and to those who so generously contributed to the Society. We raised £20000 including a £5000 donation from the Society's reserves. The Aldeburgh Business Association is now represented at our Committee meetings ensuring dialogue between the Society and the business community. The website was redesigned (thank you Emma Close-Brooks) and we have digitalised our membership forms.

Consultations have kept us busy. We helped persuade the Boundary Commission that, for the new East Suffolk Council with its much reduced number of councillors and doubled land area, Aldeburgh and Leiston should have three District Councillors. We commented on the Local Plan consultation and most importantly we are continuing to respond on the energy infrastructure projects which risk blighting our coast. We remain focussed on the mayhem that will come from the simultaneous construction of both the Scottish Power windfarms and EDF's development of Sizewell C. Thanks to Alan and Christine Collett we were able to distribute leaflets to most households in Aldeburgh encouraging residents to respond. Template letters are on the website. We are corresponding with central government departments about the lack of coherence that surrounds these projects.

We remain vigilant with respect to planning applications affecting Aldeburgh. We look to see if applications add to or detract from the town scene and consider their conformity with the local plan. We remain ever grateful to Peter Hill, the chair of our Planning sub-committee for his vigilance and sensible submissions even in the face of considerable adversity.

We had four excellent talks. Michael Strand, Development Director of the Suffolk Wildlife Trust, spoke passionately about the trust's plans to preserve and protect our natural environment in testing times. Nick Hulme, Chief Executive of the Ipswich and Colchester Hospitals NHS trust, spoke candidly to a very large audience about the challenges the trust faces in delivering health care in the current climate. Stephen Baker, Chief Executive of the new East Suffolk Council, outlined the plans for the new council and faced difficult questions from the audience about the Council's position on the proposed infrastructure projects. To conclude our season Sarah Holmes, Chief Executive of the Wolsey Theatre, together with her husband Peter Rowe, the artistic director, explored how the theatre has gone from near insolvency to its present success. They were happy to provide tips for Aldeburgh's arts community and the evening was lively. We hope to organise a trip to the Wolsey in the coming months. Our joint talk with the Library in January was a first and well received.

Our spring party in 2018 at the Red House was a great success (despite the weather). Thanks to all who helped. Our next one, to which the invitation is enclosed, is at the Pump House.

Finally, thank you to all members of the committee. New members are always welcome!

I report on the accounts of The Aldeburgh Society for the year ended 31 December 2018 set out overleaf.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts.

The charity's trustees consider that an audit is not required for this year under section 144 of the Charities Act 2011 ('the Charities Act') and that an independent examination is needed.

It is my responsibility to:

- examine the accounts under section 145 of the Charities Act,
- to follow the procedures laid down in the general Directions given by the Charity Commission (under section 145(5)(b) of the Charities Act), and
- to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination was carried out in accordance with general Directions given by the Charity Commission. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the accounts present a 'true and fair' view and the report is limited to those matters set out in the statement below.
